

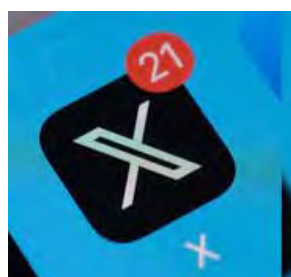
## X takes on WhatsApp, rolls out audio and video calls

New Delhi, (IANS) In a bid to take on Meta-owned WhatsApp, Elon Musk-owned X Corp has started to roll out support for audio and video calls.

Several X (formerly Twitter) users received a notification while opening the social media app that reads: "Audio and video calls are here!"

There's also a new "Enable audio and video calling" toggle with in the app's settings. It says you can "turn the feature on and then select who you're comfortable using it with," reports The Verge.

"Early version of video and audio calling on X," posted Musk. X teased users with



a cryptic post saying "ready for it...?" before the new feature started appearing.

The new feature allows audio and video calls from people in your address book, people you follow, verified users, or all of the three options.

X CEO Linda Yaccarino had confirmed last month that video calls will arrive on the platform as part of its transition into an "everything app." The X

CEO said that soon, "you'll be able to make video chat calls without having to give your phone number to anyone on the platform".

Musk always wanted Twitter to become "an everything app" like China's WeChat. X will soon roll out two new paid premium tiers and one of that tier with ads will cost lower than the current \$8 a month. The other tier will be a more expensive one, which will remove all ads, the billionaire said.

"Two new tiers of X Premium subscriptions launching soon. One is lower cost with all features, but no reduction in ads, and the other is more expensive, but has no ads," the X owner posted.

## Sensex plunges more than 800 points to fall below 64k mark

New Delhi, Oct 26 (IANS) The BSE Sensex is down by more than 800 points to fall below the 64,000 points mark on Thursday.

Sensex is down by 832 points at 63,216 points in morning trade amid massive selling the markets.

Among the big losers, M&M is down 3 per cent, Bajaj Finance is down 2.8 per cent, Tech Mahindra is down 2.8 per

cent, Nestle is down 2.4 per cent, Bajaj Finserv is down 2.4 per cent, Asian Paints is down 2.1 per cent.

Vaishali Parekh, Vice President - Technical Research, Prabhudas Lilladher, said Nifty plunged heavily with profit booking witnessed and extended the losses from the previous session breaching below the crucial 19,200 zone during the intraday

session further weakening the bias and sentiment overall. As mentioned earlier, a breach below 19,200 zone shall trigger for intensified selling pressure with next major support maintained near 18,800-18,600 levels near the 200 period MA. The support for the day is seen at 18,950 levels while the resistance is seen at 19,250 levels, Parekh said. V.K. Vijayakumar, Chief Investment Strategist

at Geojit Financial Services said there is risk-off in global equity markets triggered by a combination of economics and geopolitics. The Israel-Hamas conflict continues to be a major headwind for markets. If the conflict lingers for long it has the potential to impact global growth, too, when the global economy is already in the midst of a slowdown. In the near-term, however, the strongest headwind for the

market is the stubbornly high US bond yields. With the 10-year bond yield at near 5 per cent FPIs are likely to be in the sell mode. Sectors like banking and IT which constitute the largest segments of the AUM of FPIs are likely to be under pressure. This will provide opportunities for long-term investors to buy quality stocks, particularly in banking, at attractiverates, he added.

## Meta logs \$34 bn in revenue in Q3, AR-VR business remains in red

San Francisco, Oct 26 (IANS) Meta registered \$34 billion in revenue in its third quarter, up 23 per cent from the same quarter last year.

Total costs and expenses were \$20.40 billion, a decrease of 7 per cent (year-over-year) in the September quarter. Net income rose 164 per cent from a year earlier to \$11.58 billion in the quarter.

However, the company is still burning cash with its

Reality Labs division and Meta expects its operating losses there to increase "meaningfully" year-over-year. Meta's AR-VR division has lost close to \$25 billion since the start of last year. "We had a good quarter for our community and business. I'm proud of the work our teams have done to advance AI and mixed reality with the launch of Quest 3, Ray-Ban Meta smart glasses, and our AI studio," Meta Founder and CEO Mark Zuckerberg said in a statement late on Wednesday. The Meta stock initially

went up but then fell more than 3 per cent. The company had 3.14 billion family daily active people (DAP) on average for September, an increase of 7 per cent year-over-year. Facebook daily active users (DAUs) were 2.09 billion on average for September, an increase of 5 per cent. "We expect fourth quarter 2023 total revenue to be in the range of \$36.5-40 billion," said the company. Meta's Reality Labs division, which focuses on AR-VR, registered \$3.74 billion in operating losses for the quarter.

## Intel working to build ChatGPT-like apps for customers: Report

San Francisco, Oct 26 (IANS) Chip-maker Intel is reportedly working with multiple consulting firms to build ChatGPT-like apps for customers, as AI boom catches up with almost every tech company especially rival chipmakers such as Nvidia and Broadcom.

According to a report in The Information, citing sources, Intel is also selling its specialised AI, app-building software directly to corporate customers.

"Intel began the project with Boston Consulting Group (BCG) earlier this

year but has added additional consulting-firm partners," the report mentioned.

Intel was yet to comment on the report. In May this year, BCG and Intel announced a strategic col-

laboration to enable generative artificial intelligence (GenAI) using end-to-end Intel AI hardware and software, bringing fully custom and proprietary solutions to enterprise clients while keeping private data in the isolation of their trusted environments.

## Nifty closed in the green on 5 occasions in month of November for last 10 yrs

New Delhi, Oct 26 (IANS) An analysis for the month of November indicated that the Nifty had closed in the green on five occasions with an average return of 1.2 per cent in the last 10 years, JM Financial Institutional Securities said in a report.

The Nifty Mid-cap index, on the other hand, has shown a relatively stronger seasonality, closing in the green on eight occasions with an average return of 2.1 per cent, the report said.
